All classes will be held in the VIRTUAL CLASSROOM USING ZOOM. Students have the option of attending sessions at CENTURY 21 Novus Realty, 537 Newnan Rd, Carrollton, GA 30117. Price is \$450 and includes instruction, textbook, and school final exam. There is separately a qualifying exam required for licensure which is administered by Applied Measurement Professionals for the Georgia Real Estate Commission. A student that misses more than 2 hours of the scheduled classes must complete makeup. A student who misses more than 14 hours will be dropped from the class and will be required to enroll in another class to certify, IF SUCH CLASS/SCHEDULE IS AVAILABLE. The re-enrollment fee for a student who is dropped from the class is \$250 and does not include a textbook.
