There is separately a qualifying exam required for licensure which is administered by PSI for the Georgia Real Estate Commission. Information on the state exam is available at www.psiexams.com. Enrollment online may be completed at www.iret.info. A student that misses more than 2 hours of the scheduled classes must complete makeup. A student who misses more than 14 hours will be dropped from the class and will be required to enroll in another class IF SUCH CLASS/SCHEDULE IS AVAILABLE. The re-enrollment fee for a student who is dropped from the class is \$250 and does not include a textbook.
